Brief Information on CIMB-Principal Equity Aggressive Fund 3

CIMB-Principal Equity Aggressive Fund 3 is an equity fund issued by Principal Malaysia. The Fund aims to grow the value of investments over the long-term through investment in Malaysian shares.

This is neither a capital protected nor capital guaranteed fund.

Product Suitability

The recommended investment timeframe for this Fund is five (5) years or more. This Fund is suitable for investors who:

- have a long-term investment horizon;
- do not require regular income from their investment;
- seek capital appreciation over the long-term; and/or
- can accept that investment returns may fluctuate significantly over the short-term and may even be negative.
