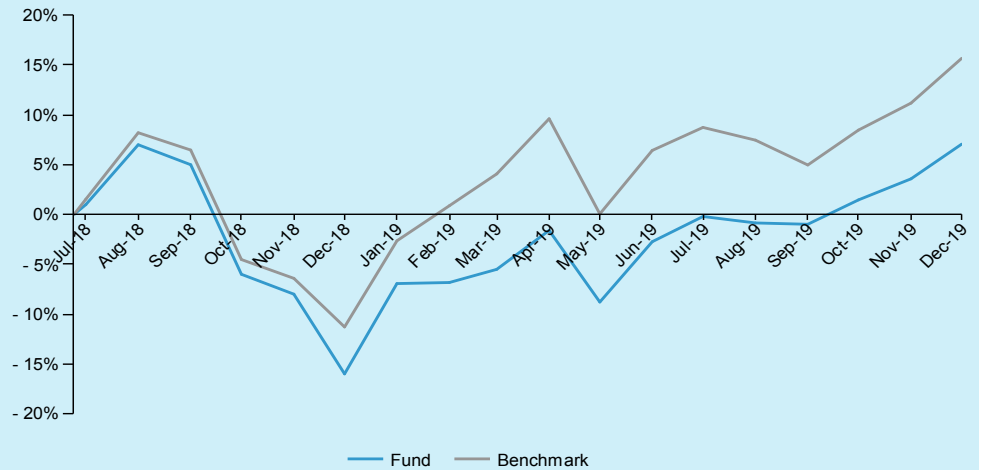

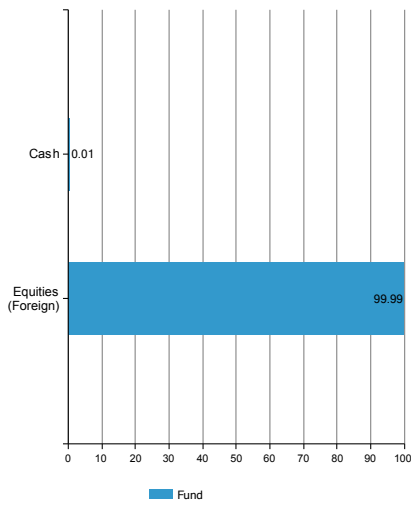

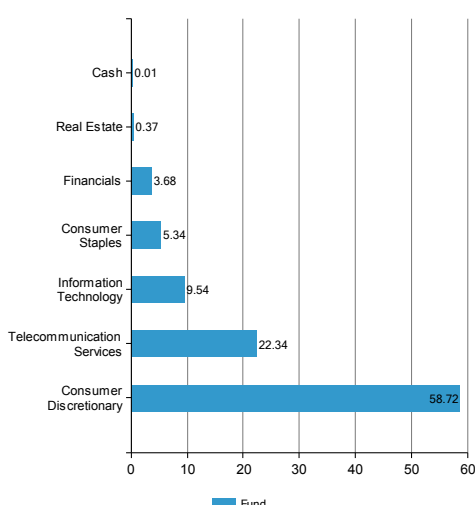

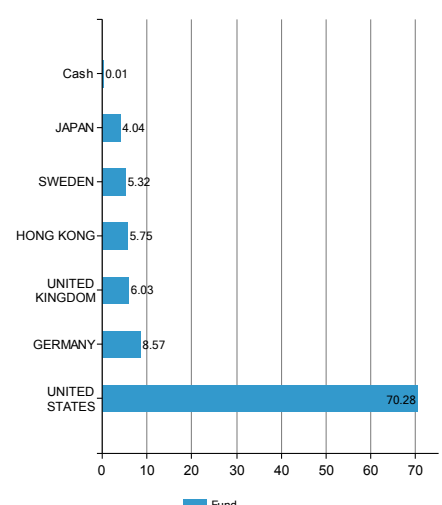
Asset Allocation (%)
