


## Principal Asia Pacific Renewables Fund - Class SGD-Hedged 31 March 2024

## **Fund Objective**

The Fund aims to achieve capital appreciation over the medium to long term by investing primarily in the Asia Pacific ex Japan region. The Fund will be actively managed with the aim of achieving stable and positive investment returns over the medium to long term. The Fund will invest primarily in companies which is domiciled in, listed in, and/or have significant operations in the Asia Pacific ex Japan region. The Fund will invest at least 70% of its total assets in equity securities of renewable energy companies. As the Fund is a qualified sustainable and responsible investment fund, the investments of the Fund will be subject to the ESG integration approach.



## **Fund Manager's Report**

The Fund was up 2.21% in SGD terms in March, underperforming the benchmark by 43 bps. YTD, the Fund is up 6.48%, outperforming the benchmark by 434 bps.

MSCI AC Asia Pacific ex Japan Index rose by 2.3% in USD terms in March. Inflation proved to be more persistent than expected in the US as headline inflation increased 0.4%MoM or 3.2%YoY in February. All eyes were on FOMC meeting if the dot plot will reflect a lower number of rate cuts this year, especially after a strong February nonfarm payrolls number too. Eventually, the Fed decided to maintain its median forecast for three cuts for this year, in line with market expectations. The Fund is investing in areas of sustainable growth such as power grid investments (needed for renewable energy penetration), electrification, nuclear energy, and industrial gas/green hydrogen. This has helped protect shareholder capital and deliver capital growth year-to-date, while we await better competitive dynamics to emerge more broadly within the renewables sector. The long-term outlook for renewables and energy transition remain bright, and will deliver rewards when competitive dynamics improve.
