Brief Information on Principal China-India-Indonesia Opportunities Fund

Principal China-India-Indonesia Opportunities Fund is an equity fund issued by Principal Malaysia. The Fund aims to achieve medium to long-term capital appreciation by capitalizing on investment ideas in undervalued listed companies which are domiciled or have significant operations in China, India and Indonesia.

This is neither a capital protected nor capital guaranteed fund.

Product Suitability

The recommended investment timeframe for this Fund is at least three (3) years. This Fund is suitable for investors who:

- want to include three (3) major emerging markets in Asia for portfolio diversification;
- wish to participate in the growth potential of the China, India and Indonesia markets;
- are willing to accept higher risks in China, India and Indonesia markets; and/or
- plan to hold their investment for the medium-term to long-term.

Avenues to Exit This Investment
