In order to achieve its investment objective, the Fund will invest at least 95% of its NAV in Class AM2-USD of the HSBC China Multi-Asset Income Fund (Target Fund). The Target Fund aims to provide income and moderate capital growth, through an active asset allocation in a diversified portfolio of a minimum of 70% of its NAV in fixed income and equity securities as well as money market and cash instruments that are related to China.


