Brief Information on Principal Institutional Bond Fund 6

The Fund is a wholesale bond fund issued by Principal Malaysia which aims to provide income and capital growth by investing primarily in bonds.

This is neither a capital protected fund nor a capital guaranteed fund.

Product Suitability

This Fund best suits you if you:

- are a Sophisticated Investor (limited to institutional investors only);
- have a medium-term investment horizon, i.e. three (3) years or more;
- want access to bond market; and
- are looking for a less volatile investment but can accept that returns may fluctuate over the short-term, i.e. less than one (1) year.

Investment policy and principal investment strategy	The Fund seeks to achieve its investment objective by investing into a portfolio of corporate bonds and Government Securities. The Fund will invest between 70% to 98% (both inclusive) of its NAV in Government Securities and corporate bonds (including commercial papers) which carry a minimum credit rating of "A3" or "P1" by RAM Ratings or its equivalent rating by MARC. The remainder of the Fund's NAV will be invested in liquid asset such as Deposits.

Key Risks

General risks of investing in a collective investment scheme	
Returns not guaranteed	The investment of the fund is subject to market fluctuations and its inherent risk. There is NO GUARANTEE on the investment returns, nor any assurance that the fund's investment objective will be achieved.
Market risk	Market risk refers to the possibility that an investment will lose value because of a general decline in financial markets, due to economic, political and/or other factors, which will result in a decline in the fund's NAV.
Inflation risk	This is the risk that your investment in the fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.
Manager risk	This risk refers to the day-to-day management of the Fund by the manager which will impact the performance of the fund. For example, investment decisions undertaken by the manager, as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error or weaknesses in operational process and systems, may adversely affect the performance of the fund.

Financing risk	This risk occurs when you obtain financing to finance your investment. The inherent risk of investing with money obtained from financing includes you being unable to service the financing payments. In the event units are used as collateral, you may be required to top-up your existing instalment if the price of units fall below a certain level due to market conditions. Failing which, the units may be sold at a lower NAV per Unit as compared to the NAV per Unit at the point of purchase towards settling the financing.
Specific risks associated with the investment portfolio of the Fund	
Credit and default risk	Investment of the Fund may involve a certain degree of credit (default) and counterparty risk. This refers to the risk of loss due to the counterparty's and/or issuer's non-payment or untimely payment of the investment amount as well as the returns on investment. This may result in a credit downgrade which will cause a decline in value of the investments and subsequently depress the NAV of the Fund. In addition, each counterparty/issuer that the Fund dealt with may issue a number of securities or a security with different tranches. Each of these securities carries its own credit rating. Thus, the Fund may expose to varying degree of credit (default) and counterparty risk given that each security or each tranche of the security has a different level of risk exposure. We aim to mitigate this credit (default) and counterparty risk by performing fundamental credit research and analysis to determine the creditworthiness of its counterparties and/or issuers as well as the credit quality of their issues.
Interest rate risk	Interest rate risk is the risk that an investment's value will be affected due to a change in the level of interest rates. Such changes usually affect the investments inversely and can be reduced by managing the duration of the portfolio via shorter or longer tenured assets depending on our view of the future interest rate trend, which is based on our continuous fundamental research and analysis.
Liquidity risk	Liquidity is defined as the ease with which a security can be sold. If a security encounters a liquidity crunch, the security may need to be sold at unfavourable price. This in turn would depress the NAV of the Fund. Generally, all investments are subject to a certain degree of liquidity risk depending on the nature of the security, market, sector and other factors. We will attempt to balance the entire portfolio by investing in a mix of assets with satisfactory trading volume and those that occasionally could encounter poor liquidity. This is expected to reduce the risks for the entire portfolio without limiting the Fund's growth potentials.
Company specific risk	There are many specific risks which apply to individual companies that may affect the growth of the Fund. Examples include the possible effect on a company of losing a key executive or the unforeseen entry of a new competitor into the market or the implications of a company's credit rating being downgraded. As a consequence, the price of any issuance by that company may fall, and subsequently may also affect the overall growth of the Fund. We aim to reduce all these risks by using diversification that is expected to reduce the volatility as well as the risk to the Fund's portfolio. In addition, we will also perform continuous fundamental research and analysis to aid the management of the Fund.
Reinvestment risk	Reinvestment risk is incurred when the investments* are not reinvested at the interest rate when the bond was initially purchased. This risk is more evident during periods of declining interest rate. If these investments* are reinvested at a lower interest rate, the returns generated from the reinvestment will be lower than the returns initially expected. * Investments in this context refer to: <ul style="list-style-type: none"> ▪ coupons earned from holding a bond; ▪ principal payments returned to the bondholder upon maturity of the bond; and/or ▪ prevailing market price of the bond if the bond is sold prior to its maturity.

Switching Fee	Since switching is treated as a withdrawal from one (1) fund and an investment into another Principal Malaysia's fund, you will be charged a Switching Fee equal to the difference (if any) between the Application Fees of these two (2) funds. In addition, we may impose a MYR100 administrative fee for every switch. However, we have the discretion to waive the Switching Fee and/or administrative fees.
Transfer Fee	A transfer fee of not more than MYR50.00 may be charged for each transfer. However, we have the discretion to waive the Transfer Fee.
Management Fee	0.26% per annum of the NAV of the Fund.
Trustee Fee	0.02% per annum of the NAV of the Fund.

Expenses directly related to Fund	Only expenses that are directly related to the Fund can be charged to the Fund. Examples of relevant expenses are audit fee and tax agent's fee.
Other charges payable indirectly by you when investing in the Fund	Any applicable bank charges and other bank fees incurred as a result of an investment or withdrawal will be borne by the investor.

Valuations

We adopt the single pricing method for any transactions (i.e. applications, switches, transfers and/or withdrawals) based on forward prices. This means that we will process your transactions request based on the NAV per unit at the next valuation point after we receive the completed relevant transaction forms from you. Please refer to “Unit Pricing” section of the Information Memorandum for more details.

Avenue to Exit This Investment

To exit from this investment, you may withdraw from the Fund, switch out of the Fund or transfer your unit holdings to another Sophisticated Investor. Please refer to the “Fees & Charges” and “Transaction Information” sections of the Information Memorandum for more details.

Withdrawals can be made from the Fund by completing a withdrawal form and sending it to our head office. There is no restriction on the frequency of withdrawals. The amount that you will receive is calculated by the withdrawal value less the Withdrawal Fee, if any. You will be paid in RM within seven (7) Business Days upon our receipt of the complete withdrawal request. You will have to bear the applicable bank fees and charges, if any.

Application Fee	- Preliminary charge on each investment.
Business Day	- Mondays to Fridays when Bursa Malaysia Securities Berhad is open for trading, and/or banks in Kuala Lumpur and/or Selangor are open for business. Note: We may declare certain Business Days a non-Business Day when deemed necessary, such as in the event of market disruption.
CMSA	- Capital Markets and Services Act 2007.
Deed	- The principal deed and any supplemental deed in respect of the Fund made between us and the Trustee, in which the Unit holders agree to be bound by the provisions of the Deed.
Deposit	- Refers to placement of fixed deposit, call/short term deposits, negotiable instruments of deposit, bank's acceptance and money market instruments issued by any financial institutions licensed under Financial Services Act 2013 and Islamic Financial Services Act 2013 in Malaysia, with maturities ranging from one (1) day to one (1) year (i.e. 365 days or 366 days in the event of a leap year).
Fund or IBF6	- Principal Institutional Bond Fund 6.
Information Memorandum	- Refers to the information memorandum dated 19 December 2019, first supplemental information memorandum dated 25 May 2023 and second supplemental information memorandum dated 26 February 2024 in respect of the Fund issued by us describing the details of the Fund.
IUTAs	- Institutional Unit Trust Scheme Advisers.
Government Securities	- Securities/Papers issued by the Government of Malaysia or Bank Negara Malaysia.

For the purpose of computing the annual Management Fee (if any) and annual Trustee Fee (if any), the NAV of the Fund should be inclusive of the Management Fee and Trustee Fee for the relevant day.

Unit holder	- The registered holder for the time being of a unit of the Fund including persons jointly so registered.
Wholesale Fund	- A unit trust scheme established in Malaysia where the units are to be issued, offered for subscription or purchase, or for which invitations to subscribe for or purchase the units are to be made, exclusively to Sophisticated Investor.
Withdrawal Fee	- A charge levied upon withdrawal under certain terms and conditions (if applicable).
