## Fund Objective

The Fund aims to provide long term capital appreciation and income through Shariah-compliant investments that invests in the global markets within the target risk range of the Fund. The Fund will invest in a diversified mix of asset classes such as Shariah compliant equities, Sukuk, Islamic gold ETF and Islamic Deposit. The asset allocation strategy for this Fund is as follows: Up to 80% of its NAV may be invested in Shariah-compliant equities; Up to 40% of the Fund's NAV may be invested in Islamic debt securities; Up to 40% of the Fund's NAV may be invested in Islamic gold ETF; and at least 2% of its NAV will be invested in Islamic Deposit.

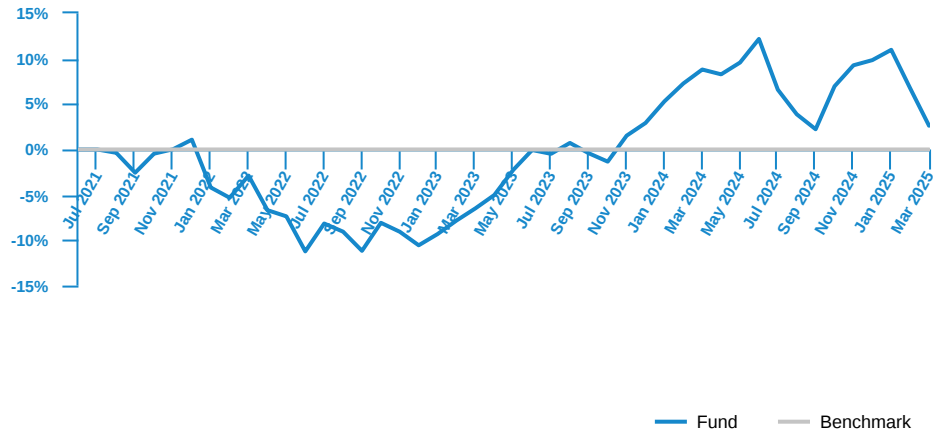

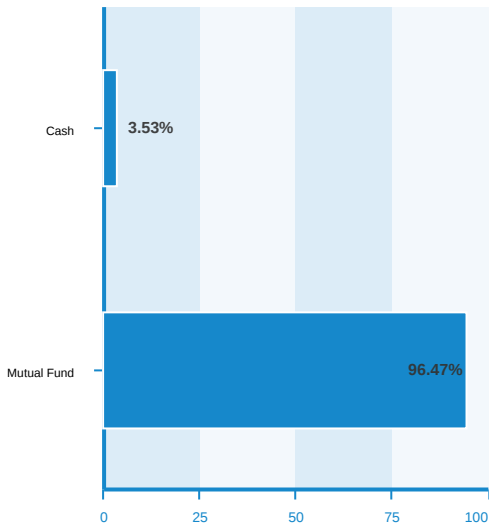

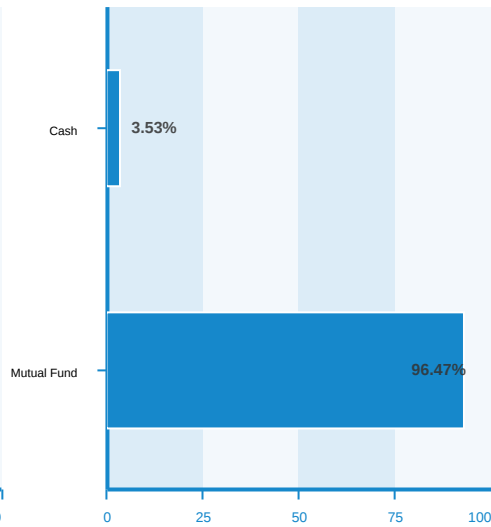

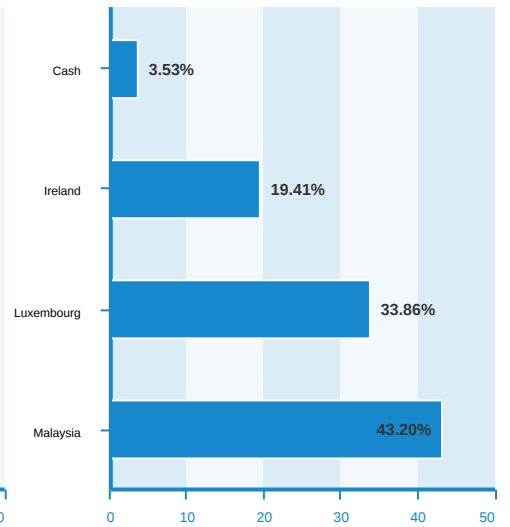
## Asset Allocation (%)
