Brief Information on Principal Malaysia Titans Fund

The Fund is an equity fund issued by Principal Malaysia. The Fund aims to maximise capital growth over the medium to long-term through the stock market. The Fund is established with a multi-class structure and is allowed to establish new Class(es) from time to time without your prior consent.

This is neither a capital protected nor capital guaranteed fund.

Product Suitability

This Fund is suitable for investors who:

- have a long-term investment horizon;
- want a well-diversified of equities in Malaysia;
- seek capital appreciation over long-term; and
- are comfortable with a higher volatility and can accept that investment returns may fluctuate over the investment period.

General risks of investing	General risks of investing in a fund						
Returns and capital not guaranteed The investment of the fund is subject to market fluctuations and its inherent risk. Th GUARANTEE on the investment which includes your investment capital and returns, nor any that the fund's objective will be achieved. You should also note that the fund is neither guaranteed fund nor a capital protected fund. However, we reduce this risk by ensuring management of the assets of the fund based on a structured investment process.							
Market risk	This risk refers to the possibility that an investment will lose value because of a general decline in financial markets, due to economic, political and/or other factors, which will result in a decline in the fund's NAV.						
Inflation risk	This is the risk that your investment in the fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.						

Financing risk	This risk occurs when you obtain financing to finance your investment. The inherent risk of investing with money obtained from financing includes you being unable to service the financing payments. Stock specific risk	Prices of a particular stock may fluctuate in response to the circumstances affecting individual companies such as adverse financial performance, news of a possible merger or loss of key personnel of a company. Any adverse price movements of such stock will adversely affect the Fund's NAV.
Risk associated with investment in warrants and/or options	There are inherent risks associated with investment in warrants and/or options. The value of warrants and/or options are influenced by the current market price of the underlying security, the exercise price of the contract, the time to expiration of the contract and the estimate of the future volatility of the underlying security's price over the life of the contract. Currency risk	Currency risk at the Fund's portfolio level
·	As the investments of the Fund may be denominated in currencies other than the base currency of the Fund, any fluctuation in the exchange rate between the base currency of the Fund and the currencies in which the investments are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the investments are denominated in depreciate against the base currency of the Fund, this will have an adverse effect on the NAV of the Fund in the base currency of the Fund and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.

Cyber security risk	This is the risk arising from cyber-attack on e-Wallet App. Should the e-Wallet App be compromised, it may result in unauthorised transactions pertaining to the Fund. Further to that, your investment-related information and personal data may be leaked. All transactions through e-Wallet App and/or the Fund may be temporarily suspended, in which you may not be able to transact through e-Wallet App or in the Fund due to cyber-attack.
Functionality risk	This is the risk that the e-Wallet App does not operate as intended due to factors including but not limited to connectivity and interface issues. If the e-Wallet App does not function as expected, your transaction through the e-Wallet App may not be correctly processed and/or completed.

Avenues to Exit This Investment

For the financial year under review, the Fund's total return decreased by 1.85%, while the benchmark dropped by 2.03%. As such, the Fund outperformed its benchmark by 18 bps amid the inflation worries and the consequence of tightening monetary policies.

Business Day - Mondays to Fridays when Bursa Malaysia Securities Berhad is open for trading, and/or banks in Kuala

Lumpur and/or Selangor are open for business.

CIS - Refers to collective investment schemes.

Class D - The Class issued by the Fund denominated in MYR and differentiated by feature such as type of eligible

investors and/or transaction methods.

Deed - The principal deed and all supplemental deed in respect of the Fund made between us and the Trustee, in

which Unit holders agree to be bound by the provisions of the Deeds.

Distributors - Any relevant persons and bodies appointed by Principal Malaysia from time to time, who are responsible for

selling units of the Fund, including Principal Distributors and IUTA.

e-Wallet App - Mobile application of the e-wallet that allows an individual to make electronic transaction, which includes

but not limited to Touch 'n Go e-wallet.

e-Wallet Provider - Refers to e-money issuer approved by Bank Negara Malaysia, which includes but not limited to TNG Digital

Sdn Bhd.

FTSE - Financial Times and Stock Exchange.

Fund or TI-MT - Principal Malaysia Titans Fund.

GUTF - Guidelines on Unit Trust Funds issued by the SC.

IUTA - Refers to Institutional Unit Trust Schemes Adviser, a corporation registered with Federation of Investment

Managers Malaysia and authorised to market and distribute unit trust schemes of another party.

Management Fee - A percentage of the NAV of the Class that is paid to us for managing the portfolio of the Fund.

Master Prospectus Refers to the master prospectus 10 July 2023 and first supplementary master prospectus dated 27 October 2024 issued by us describing the details of the Fund.

MYR - Malaysian Ringgit.
NAV - Net Asset Value.

NAV of the Class - The NAV of the Fund attributable to a Class at the same valuation point.

NAV of the Fund - The value of all the Fund's assets less the value of all the Fund's liabilities, at the point of valuation. For the purpose of computing the annual Management Fee (if any) and annual Trustee Fee (if any), the NAV of the

Fund should be inclusive of the Management Fee and Trustee Fee for the relevant day.

NAV per unit - The NAV attributable to a Class divided by the number of units in circulation for that Class, at the valuation

point.

Principal - Refers to the authorised unit trust scheme consultants registered with Principal Malaysia. Distributors
