Fund Objective

The Fund aims to achieve capital appreciation through investments in one (1) collective investment scheme, which invests in mobile internet and connectivity related securities. The Fund is a feeder fund and it invests in a single CIS, i.e. Neuberger Berman 5G Connectivity Fund (Target Fund). The Fund may also invest in liquid assets for liquidity purpose. In order to achieve its investment objective, the Fund will invest at least 95% of its NAV in the Target Fund and may also invest up to 5% of its NAV in liquid assets for liquidity purpose.





Fund Manager's Report

The Fund increased by 1.06% during the month, outperformed the benchmark by 0.08%.

Global equity markets experienced significant volatility in April dominated by tariff related headlines, marked by sharp selloffs and moments of relief U S equities experienced their worst single day drop in five years after President Trump announced a tariff increase to nearly 20%, sparking fears of slowing global growth and rising input costs. The situation escalated as China retaliated with 34% tariffs, further amplifying economic uncertainty and prompting bond markets to price in significant Federal Reserve rate cuts. Relief came later as Trump announced a 90 day pause on new tariffs and signaled a willingness to reduce tariffs on China, contingent on a trade agreement, though China denied active negotiations. Investors welcomed temporary exemptions for electronics tariffs, including smartphones and semiconductor chips, offering short term relief to companies while preparing for broader tariffs ahead.

In the face of continued macro uncertainty, we place strong emphasis on quality but are ready to capture tactical opportunities. We keep our focus on areas with strong earnings tailwinds and visibility while maintaining our valuation discipline. Next generation connectivity continues to be the foundation of current and future technological innovations. We are positive on the beneficiaries of the acceleration in AI, the strategic semiconductor industry, and rising digital adoption.
