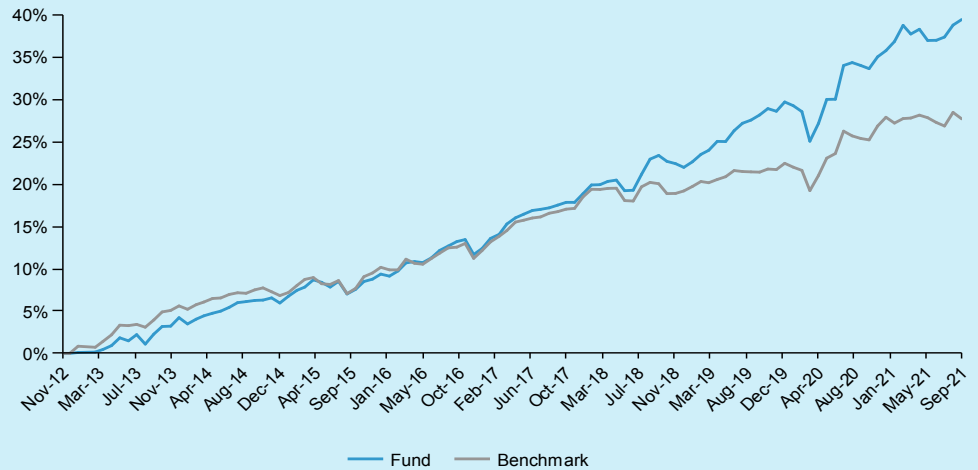

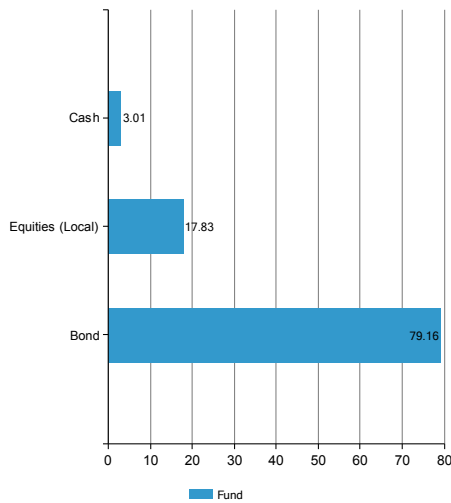

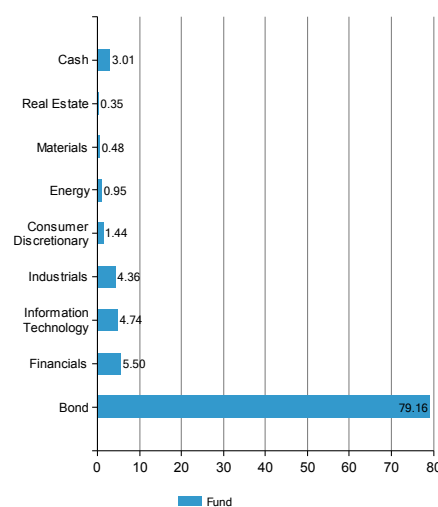

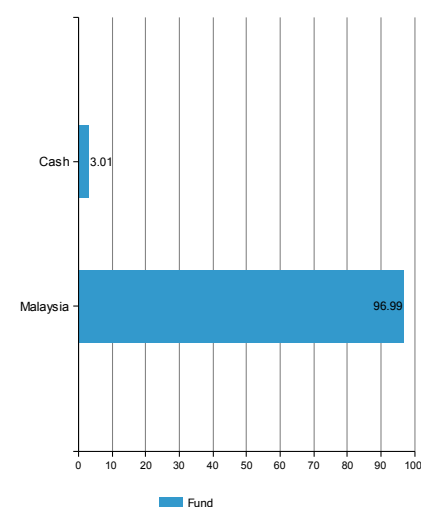
## Asset Allocation (%)
