
Fund Objective

The Fund seeks to achieve its objective by investing in USA equities and other equity related securities by focusing its investment primarily in companies with market capitalization of not more than USD 30 billion and a part of the Fund's NAV in companies with market capitalization of more than USD 30 billion. Minimum 70% of its NAV will be invested in equities and other equity related securities; and The balance of its NAV will be invested in money market instruments and/or Deposits.


