Fund Objective

The Fund is a feeder fund and it invests at least 95% of its NAV in a single collective investment scheme, i.e. HSBC Portfolios - World Selection 5 (Target fund). The Fund will also maintain up to 5% of its NAV in liquid assets for liquidity purposes.








Asset Allocation (%)
