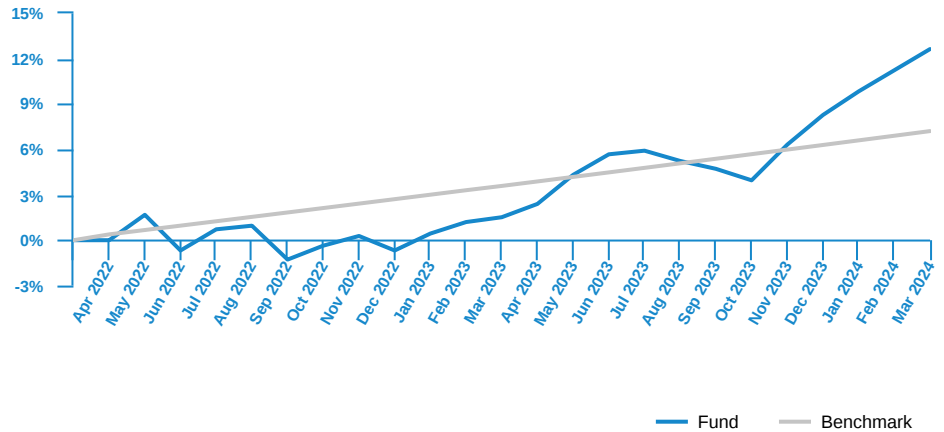
## Fund Objective

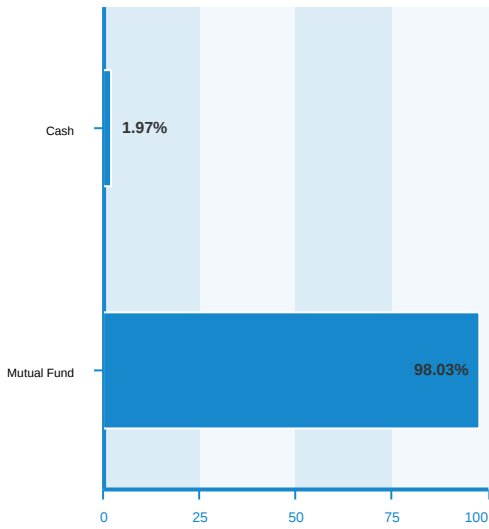

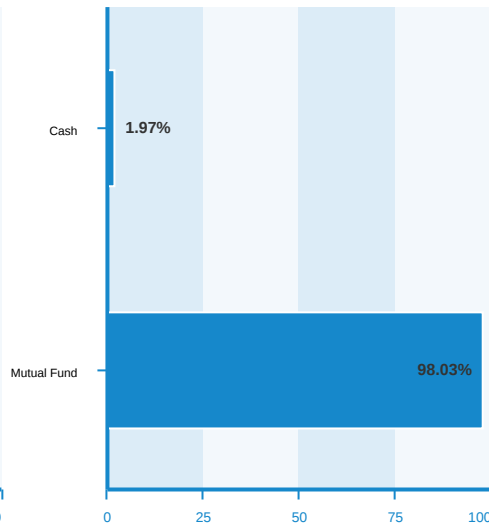

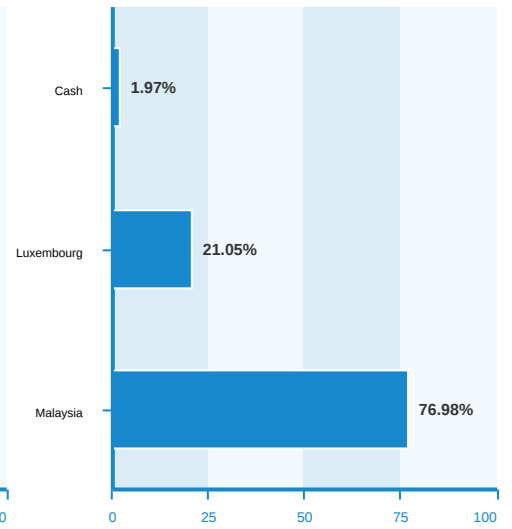
## Asset Allocation (%)
