Brief Information on Principal Malaysia Titans Fund

The Fund is an equity fund issued by Principal Malaysia. The Fund aims to maximise capital growth over the medium to long-term through the stock market. The Fund is established with a multi-class structure and is allowed to establish new Class(es) from time to time without your prior consent.

This is neither a capital protected fund nor a capital guaranteed fund.

Product Suitability

This Fund is suitable for investors who:

- have a long-term investment horizon;
- want a well-diversified of equities in Malaysia;
- seek capital appreciation over long-term; and
- are comfortable with a higher volatility and can accept that investment returns may fluctuate over the investment period.

General risks of investing in a fund				
Returns and capital not guaranteed	The investment of the fund is subject to market fluctuations and its inherent risk. There is NO GUARANTEE on the investment which includes your investment capital and returns, nor any assurance that the fund's objective will be achieved. You should also note that the fund is neither a capital guaranteed fund nor a capital protected fund. However, we reduce this risk by ensuring diligent management of the assets of the fund based on a structured investment process.			
Market risk	This risk refers to the possibility that an investment will lose value because of a general decline in financial markets, due to economic, political and/or other factors, which will result in a decline in the fund's NAV.			
Inflation risk	This is the risk that your investment in the fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.			

This risk occurs when you obtain financing to finance your investment. The inherent risk of investing with money obtained from financing includes you being unable to service the financing payments. Avenues to Exit This Investment

There is no restriction on the frequency of withdrawals and no Withdrawal Fee will be charged.
