By signing this consent form, I acknowledge that:

- 1. Redeem & Reinvest request is only accepted for individual account (i.e., joint account is not allowed).
- 2. Redeem & Reinvest is only available for MYR funds/class.
- 3. The Redeem & Reinvest request is processed as a redemption of my unit holdings from UTF and as a new investment into the selected PRS fund.
- 4. There are fees, expenses and charges (e.g., sales charge) involved in the investment of PRS fund. Investors are advised to consider them before investing in the PRS fund.
- 5. The redemption proceeds of my unit holdings from UTF ("Redemption Proceeds") will not be paid to my bank account. The UTF redemption proceeds will be transferred directly into Principal's PRS collection account to facilitate my new investment into PRS fund.
- 6. The investment into PRS fund will be processed only after the Net Asset Value ("NAV") per unit of UTF is available.
- 7. The NAV per unit of redemption for UTF and the NAV per unit of investment into PRS fund may be of different business days.
- 8. The complete UTF Redemption Form, PRS Joint Account Opening Form (for new PRS investor) and PRS Contribution Form (for existing PRS investor) must be submitted to Principal for processing together with this consent form. Incomplete applications will not be processed until Principal has received all the necessary information and the required forms.
- 9. The processing of investment into PRS fund will generally be completed within five (5) business days after the redemption of my unit holdings from UTF is completed.
- 10. Principal may accept or reject this switching request for any reason whatsoever.
