- 2.3 Principal will not be responsible for any loss arising from complying with the Applicant's instructions and the Applicant shall indemnify Principal in full in respect of any matter arising from such instructions.

3. RIGHTS OF PROVIDER

- 3.1 Principal reserves the right to accept or reject any application in whole or in part thereof without assigning any reason in respect thereof without compensation to Applicant and the duly completed form received by Principal is deemed irrevocable by the Applicant.
